### Prices

- All Prices are correct at the time of issue and are subject to change without notice.
- All prices are GST inclusive where applicable.
- Insurance is available at an additional charge.
- Where "Free Post" is applicable, Insurance is still an additional charge.

### Payment

- All purchases must be paid for in full prior to shipment of goods.
- Lay-By purchases must be paid in full prior to shipment of goods.
- Lay-By total cost (Inc. postage if applicable) is divided by 4 and the first installment paid immediately.
- Second, Third and Final payments are to be made at equal monthly intervals.

### Acceptable Payment Methods

- Direct Deposit. (Preferred)
- Australian Money Order
- Personal/Bank Cheque (AUSTRALIAN ONLY) (Must allow 7 Business days for clearance)
- Pay Pal (A 3.25% Surcharge applies to this payment method only)

### Supply

- Capricorn Trading reserves the right to refuse or reduce supply to any individual, company or destination for any reason, including but not restricted to, the unavailability of any product, an error in the price or description, failure in payment, or where fulfillment of the order may expose the company to unnecessary risk.

### Availability

- All items shown are subject to availability and may be withdrawn at any time without notice.

**Delivery** Our estimated postal lodgment time is 2 to 3 working days from receipt of final payment..

**Ordering** Orders can only be placed by people legally able to enter into a contract.

### Lay-by

- Minimum order of \$200.00 not including postage if applicable.
- Payments to be made at a Maximum 4 monthly installments.
- If installments are made by Pay Pal then a 3.25% Surcharge applies to each payment.
- 1st Payment is required with order, 2nd, 3rd and 4th payments to be made at equal monthly intervals
- Once order has been placed it cannot be added to or part delivery.
- If a Lay-By is cancelled, a 15% (of the total Lay-By) Administration charge will apply.

### Special Orders

- Any large orders requiring a Special Order from the Mint must be paid for prior to delivery.
- Any cancellation of a Special Order a cancellation charge of 10% will apply to the total amount.

### Shipping

- All Shipping costs are subject to change without notice.
- Express Post is preferred shipment for items posted within Australia.
